- (3) Students will do at least one Art-Integrated Project work in each subject as part of Subject Enrichment Activity which should be trans-disciplinary in nature.
- (4) No detention policy as per RTE will continue to be followed up to VIII.
- (5) Multi-disciplinary Project (MDP) for Classes III to VIII will continue to assess the Creative skills and performance of the students. **Only one MDP is to be awarded per term for all subjects.**

**General guidelines to be followed:**

**For Middle Classes (VI to VIII):**

- (1) At least 30% Competency Based Questions including CCT skill questions should be incorporated in all kinds of Pen-Paper Test.
- (2) For Term-II syllabus for Classes VI to VIII, 10%, 20% and 30% syllabus of the Term-I will be included for Classes VI-VIII respectively. The Deputy Commissioner of the Region will intimate 10%, 20% and 30% syllabus of Term-I for each subject of Classes VI-VIII to the students/teachers in advance.
- (3) Subject Enrichment Activities (SEA), Written Work & Note Book Submission (WW&NBS), Multi-disciplinary Project (MDP) and Learner's Diary (LD) (Reflective Practices) need to be conducted before pen paper test.
- (4) Students will do at least one Art-Integrated Project work in each subject as part of Subject Enrichment Activity which should be trans-disciplinary in nature.
- (5) No detention policy as per RTE will continue to be followed up to VIII.
- (6) Multi-disciplinary Project (MDP) for Classes III to VIII will continue to assess the Creative skills and performance of the students. **Only one MDP is to be awarded per term for all subjects.**

- (5) Constructed response questions (Short Answer/Long Answer type Questions, as per existing pattern) = 40%.
- (6) Curriculum document released by the Board for the Academic Session 2023-24 and the Sample Question Papers may also be referred to for details of the QP design of individual subjects.
